188th Session of the Philadelphia and Baltimore Communion Service Tuesday, May 23, 2017

The 188th Session of the Philadelphia and Baltimore Conference began at 7:10 p.m. with the conference singing "All Hail the Power of Jesus Name", as the Conference Evangelist, Pastors, Presiding Elders and the Right Reverend William Darin Moore, Presiding Prelate of the Mid-Atlantic Episcopal District processed into the sanctuary. The Rev. Dr. William E. Kelly, Presiding Elder of the Philadelphia-Eastern Shore District served as the Worship Leader following the program as printed. The Rev. Dr. Tresa Turner, Rev. Willie Dixon, Rev. Faith Savoy, Rev. Jonathan Counts, Rev. Dr. Vernon Shannon, and the Rev. Cynthia Summers served as program participants. The John Wesley AME Zion Church (Washington, DC) and the Contee AME Zion Church (Washington, DC) rendered musical selections.

The Ministry of Kindness offering was received in the amount of \$2,104.01; afterwhich, the Rev. Lowell A. Williams, Presiding Elder of the Baltimore District presented Bishop W. Darin Moore, the Presiding Prelate of the Mid-Atlantic Episcopal District. Bishop W. Darin Moore graciously greeted the Conference and acknowledged the presence of Bishop Marshall H. Strickland, our Missionary Supervisor Mrs. Devieta Moore, and the immediate past Supervisor, Mrs. Georgia M. Thompson, Presiding Elders, General Officers from the WHOMS Society, Christian Education Department, Connectional Lay Council and Judicial Council. Bishop Moore acknowledged the presence of Dr. Helen Scott Carter who led the Sunday School literature uniform series of the National Council of Churches. Bishop Moore greeted every one of every rank and file within the bounds of the conference.

Bishop Moore presented the Communion Preacher in the personage of the Rev. Mark Anthony Thomas, Pastor of the Contee AME Zion Church to proclaim the Communion Message. The Contee Choir sang the sermonic selection. The Rev. Mark Thomas acknowledged the personalities of Rev. Dr. Lewis M. Anthony, Bishop Moore and the Supervisor, Bishop Marshall H. Strickland, his wife, family and members of the Contee Church for their love and support.

Rev. Thomas preached from the Matthew 26:26, utilizing the subject: We Don't Take Communion. Pastor Thomas lifted up three poignant points which included: First, Jesus takes what is imperfect in His hands and raises it to God. The imperfect gets blessed in the hands of Jesus. Secondly, brokenness is a part of everyone's story. Like the pieces of a broken mirror held together, we can still be used in our brokenness when Jesus holds us together. And, thirdly, Jesus communes us, feeds us and cleans us up. Using the analogy of a stray dog named "Mutt-Mutt", who was cleaned up, provided for and loved by his master; we should go out to tell someone what the Master has done for us. Following the message Rev. Mark Thomas extended the Invitation to Discipleship and offering prayer. The Invitational hymn was "Just As I am". The Rev. Dr. David McClendon gave the offering appeal and prayer.

Bishop Moore asked the Rev. Dorothy Patterson from the New Jersey Conference who also supports the work of the Mid-Atlantic in Guyana to greet the conference. 188th Session of the Philadelphia and Baltimore Wednesday Morning Bible Study – Rev. Dr. Bernard Richardson Wednesday, May 24, 2017

The Wednesday Morning Session began with devotion led by the Rev. Scot C. Moore. Following devotion Bishop W. Darin Moore presented Dr. Bernard Richardson, Dean of the Howard University School of Divinity. Dr. Richardson greeted the Conference and thanked the A.M.E. Zion Church for its role in his life and ministry. After a powerful meditation moment Dean Richardson presented on prayer, more specifically "Praying in Jesus' Name". Dean Richardson integrated with his own personal experiences several highlights regarding prayer:

- 3. All of our faults and failures are valid material for prayer. "Our prayers ought to be as messy as our lives".
- 4. In prayer God will introduce you to yourself. Like Jacob, the limp is the stuff we have to go through. God hide some sins and some he will expose to that we cannot destroy ourselves.

Wednesday Morning Business Session – Bishop W. Darin Moore, Presiding Wednesday, May 24, 2017

Bishop Moore called for the report of the Credentials Committee. Each District representative called the names of the delegates and alternates for each respective district. A motion was received by Presiding Elder Lowell Williams to adopt the report of the rules committee, seconded by the Rev. Dr. Heath Cheek. The motion carried.

The Rules Committee report was given by Chairperson, Rev. Dr. Darrell Gaskins. A motion to adopt the Rules Committee report was made by Bro. Chuck Williams, seconded by P.E. Myrtle Bowen. An amendment was offered by the chair to have the first 10 rows across he sanctuary in the five sections across to constitute the bar

The Nominations Committee chaired by the Rev. Scot C. Moore was given. A motion to receive those persons elected by the nominating committee was made by Rev. Dr. Alie Harper, Jr. and seconded by Dr. Paul Hoggard. The motion carried.

The Secretariat called the Conference Roll and made the necessary corrections. The **Northern Virginia District** and **Harrisburg Districts** were called without correction.

Wednesday Morning Business Session – Bishop W. Darin Moore, Presiding Wednesday, May 24, 2017

- The Philadelphia-Eastern Shore District will determine the status of the Rev. Dr. Joy Carrington and advise Bishop Moore prior to the First Checkup Meeting.
- A motion was made by Dr. William Kelly to honorably withdraw the Rev. Kenneth Hawley (at his request), seconded by Rev. Damon Carver. The motion carried.
- Bishop Moore advised P.E. Kelly to send the Rev. Henry Koffa a letter regarding his status in the Conference, to determine if a trial is warranted to drop Rev. Koffa. This will be dealt with at the 1st Checkup meeting.

Bishop Moore instructed the Conference of the proper process for withdrawing from the Conference if you are in full connection. The conference was instructed about the Orders of the Ordained Minister, and that our reception of these orders are a gift from the church; and should be returned in the event we leave the church. Bishop Moore also advised that persons excused from the Conference also need to meet their financial obligations. During his time of Instruction Bishop Moore taught on the difference between being located (in the local church) and a Superannuated Minister that is retired.

• The Rev. Michael A. King advised the conference that the Rev. Nancy Hawes should not be located but rather retired and should be listed as Superannuated.

The roll of the **Washington District** was called at which time the Rev. Linda Fox a minister on trial requested by letter to be withdrawn. A motion was made by the Rev. Mark Thomas, seconded by Rev. W. Ray Douglas for her withdrawal. The motion carried.

- The Rev. Cyprian Chieke is to be sent a letter regarding his status in the Conference, to determine if a trial is warranted to drop Rev. Chieke. This will also be dealt with at the 1st Checkup meeting. The same action is to be taken regarding the Rev. Thea Webster Wells of the Union Wesley AME Zion Church.
- Bishop Moore paused momentarily to ask the secretariat to call the name of our sitting Bishop at the time of his death, The Right Reverend Richard Keith Thompson. The Conference stood in tribute to Bishop Thompson.
- The secretariat was asked to determine if the name of the Rev. Gary W. Burns and Sis. Gwendolyn Burns should have been included in the role until their transfer to North Carolina. Bishop Moore advised the secretariat to review the statistical report to see if Dr. Burns' name was previously listed as transferred.

The roll of the **Baltimore District** was called at which time Bishop Moore reminded the Conference that all ministers have an obligation to answer the roll, and that all absences must be requested from him.

• The Rev. Florence D. Crawford requested to be withdrawn. Bishop Moore advised her Pastor the Rev. Adrian Nelson, II to receive her credentials so that she might be withdrawn honorably.

188th Session of the Philadelphia and Baltimore Thursday Morning Bible Study – Rev. Dr. Bernard Richardson Thursday, May 25, 2017

The Wednesday Morning Session began with the singing of "Blessed Assurance" and prayer by the Rev. Marlon Carter. Following devotion Bishop W. Darin Moore presented Dr. Bernard Richardson, Dean of the Howard University School of Divinity. Dr. Richardson greeted the Conference again, and shared that he would speak briefly on the absence of God after sharing in discussion with Dr. Vernon Shannon. Dean Richardson began with a collective meditation entitled "I Had to Love You Differently". Dean Richardson began his presentation talking of the absence of God. Dean Richardson noted in his presentation:

- O We have to grow in our understanding of God, using as a scriptural launching pad Acts 17:26-28a
- O Sometimes we must pray the scriptures because we cannot always feel the presence of God when we pray. It's not a bad thing, it's a natural thing. God does this so we can purify ourselves and go deeper in God, to grope after God.
- o We must be careful not to limit the ways God speaks to us, and we must learn how to live in the moment, and not miss what is happening now by looking ahead.
- o There are times when God will call us to do something new. It doesn't require us to leave or have a drastic change. We can be in our place of calling and miss it because we want what others have. It requires changing our understanding of God and who God is.
- o When we don't feel the presence of God in our lives we need to reflect. In the darkness and silence we sometimes see and hear God clearer.

Following the morning Bible Study, Bishop Moore asked Rev. Dr. Rita Colbert to proceed with the business of the conference to include the Presiding Elder's reports. **Rev. Dr. Monica Hargrove of the Northern Virginia District** presented her report electronically. A motion to receive her report was made by the Rev. Samuel Whittaker, seconded by the Rev. Edgar S. Bankhead. Unreadiness was offered by the Rev. Samuel Whittaker and the Rev. Karen Kennedy who presented the Presiding Elder an expression of love. The motion carried.

- 1. We can nothing without the power of God
- 2. The power of God comes through the Holy Spirit
- 3. We have stuff in our inventory we need to purge, and re-stock with hope, faith and love.

School of the Prophets Thursday Afternoon Thursday, May 25, 2017

The Rev. Scot Moore led the conference in singing followed by Bishop W. Darin Moore noting that only the Philadelphia and Baltimore has three resident Bishops (Bishop Marshall Strickland, Bishop Warren Brown and Bishop Dennis Proctor). Bishop Moore invited Bishop Marshall H. Strickland to greet the conference. Bishop Strickland noted that there is a shift in the land, and that the greatest show on earth is not over. He stated our task was to transform culture, but we have allowed culture to transform us. We must be the voice of the voiceless.

Bishop Moore acknowledged that Bishop Strickland is a National Treasure. Following Bishop Strickland Bishop Moore acknowledged Mrs. Aurelia Brown and presented Bishop Warren M. Brown. Bishop Brown thanked Bishop Strickland for his thought provoking thoughts about culture and the church. Bishop Brown stated that after reflecting there were things he wished he could apologize for and about. However, there is much in life he will not apologize for, including his heritage in the AME Zion Church and his calling. Bishop Moore expressed his appreciation for the words of wisdom and insight from our retired Bishops.

School of the Prophets Thursday Afternoon

Bishop expressed his love for preaching, not empty preaching but prophetic, passionate and substantive preaching. Bishop Moore presented the Rev. Dr. Jerry Carter, who has intellect and anointing. (See program for official bio). The conference received Dr. Carter with a warm applause.

Rev. Dr. Jerry Carter - "Purposeful Preaching"

Preaching involves some roots (the subterranean portion of our preaching), what is the foundation of our preaching. As a springboard Dr. Carter used the text I Kings 19:7-; presenting from the subject: "A Pregnant Silence: Disconnecting in Order to Connect". He stated that technology draws us towards something but takes us away from something as well. In this age, we can never be absent any more. We are more comfortable with technology than each other. We are disconnected from solitude and silence, due to technology.

Elijah discovered at Horeb how pregnant and powerful silence can be. The silence was:

- 1. Pregnant with an encounter with a presence the silence in Elijah's life made more noise than the wind, earthquake or fire, and prepared Elijah for a connection with the Holy. There is a call on the preacher to spend time in silence and solitude.
- 2. Strength for the pilgrimage silence calls Elijah out to the mouth of the cave and the Lord tells him to go back the way he came, which was a way of deserts and mountains, which shows the Lord gave Elijah strength before he gives him a solution.
- 3. A reaffirmation of purpose just when we are ready to quit, God reaffirms our purpose in moments of silence. "Garden time gets us ready for Calvary time..."

We were challenged to recommit ourselves to silence and solitude with the Lord. Dr. Carter recommended the following readings: Michael Harris – The End of Absence

Transitioning to the afternoon Business Session, Bishop W. Darin Moore, called for the Pastors and Delegates of the Northern Virginia District, requesting a praise and prayer report from each church.

The Rev. Jeremiah Hicks the Worship Leader for the evening began worship at 7:40 p.m. The Rev. 

At 2:50 p.m. the Rev. Scot Moore led the conference in praise and worship. Bishop W. Darin Moore presented the Rev. Jerry Carter for the School of Prophets. Dr. Carter reminded us that the roots of preaching impacts the fruit of preaching. Dr. Carter opened with his desire to share what preaching looks like in the 21st Century (II Chronicles 20:14).

Dr. Jerry Carter, Presenter

Theme: Standing in the Assembly: A Reconsideration of the Place and Future of Preaching

Paul admonishes that there is no hearing without a preacher. The question before us is, is preaching still relevant. Has preaching in the black church been eclipsed by praise and worship? Large churches used to signify good preaching. Scholars believe preaching has run its course and that it was relevant when we were a Word-based culture. The future of preaching may be dependent or contingent upon five concepts:

- 1. Authenticity people want to see that the preacher has clay feet. The brokenness of the preacher resonates with the brokenness of the people.
- 2. Authority The preacher must have a humble authority. We are connected to a network that we can't see... we have "exousia".

- 3. Variety the preacher cannot be enslaved to one particular style or approach. Preachers are using multi-sensory preaching.
- 4. Contextuality the preacher must preach with a consciousness of the world around him/her. We must not reflect the world, we must offer people something different.
- 5. Spirituality we must preach with the influence of the spirit. God works through our feeble and fractured words when the spirit shows up.

Bishop Moore challenged the conference to put the root and fruit of preaching together, and thanked Dr. Carter for pouring into the Philadelphia and Baltimore Conference. Recommended reading - Jeffrey Steven: The Future of Preaching

Bishop Moore called for the Conference Evangelists Reports. They were instructed to come forward to give one praise report and one prayer request. The Districts reported respectively in the following order: Baltimore District, Harrisburg District, Northern Virginia District, Philadelphia and Eastern Shore, and Washington District. A motion to receive and refer the reports was made by Rev. Lowell A. Williams, seconded by Dr. Myrtle Bowen.

The Philadelphia and Baltimore Conference Trustees reported. A motion to receive the report was made by Dr. Alvin T. Durant, seconded by Dr. William Kelly. The motion carried.

Prior to the Admissions Report, Bishop Moore that the committee chairperson is new as a result of Dr. Anthony's illness. The Admissions Committee reported with the following actions.

- Sis. Qutanna D. Brown was admitted on trial and placed in 3rd year studies.
- Bishop Moore shared with the conference that all background checks should be done prior to issuing a local preachers license. Those being presented at this conference will need to have their background checks prior to the first checkup meeting.
- Bro. George H. Lucky was presented to be admitted on trial although the committee reported he had not submitted his educational documentation. Bishop Moore advised the conference that persons must attend an accredited theological institution. We recognize school from the Association of Theological Schools. Bishop Moore decided to delay Bro. Lucky's admission until the firs checkup meeting.

A motion to receive on trial those persons the Admissions Committee recommended was made by Dr. Myrtle Bowen, seconded by Dr. Luther McKinney. The motion carried.

The 188th Session of the Philadelphia and Baltimore Afternoon Business Session Friday, May 26, 2017

Dr. Adrian Nelson gave the report of the Conference Examiners. Bishop Moore conveyed that he excused Sis. Jeanette Banks. A motion to approve the Examiners report was made by Rev. Lowell Williams, seconded by Dr. Myrtle Bowen. The motion carried.

Bishop Moore shared his belief that the Admissions Committee must ensure that persons address prescribed questions while Examiners deal only with curriculum. Holy Orders deals with the ordained life. Bishop Moore stated that he prefers the Examiners deal with their studies, and then refer them back to the Admissions Committee to address questions of regarding persons ministry journey.

The Admissions Committee recommended that Rev. Marlon Carter, Sis. Carolyn McGee, Sis. Beverly Jones and Bro. Marvin Spriggs be admitted into full connection. Bishop Marshall H. Strickland spoke to the candidates about their entering an itinerant ministry. Bishop Moore informed the candidates that over time we develop a sense of entitlement, and we forget our first love. The candidates were asked the questions in Chapter Two – The Reception of Preachers and Ministers, part II, paragraph 196 of the 2016 Book of Discipline.

A motion to admit the aforementioned persons into full connection was made by Dr. Monica Hargrove, seconded by Dr Bowen. The motion carried. The right hand of fellowship was extended by Bishops W. Darin Moore, Bishop Marshall H. Strickland, Bishop Warren M. Brown and the Presiding Elders of the Philadelphia and Baltimore District.

A motion to elect Sis. Beverly Jones, Sis. Carolyn McGee and Bro. Marvin Spriggs to the office of Deacon. A motion was made by the Rev. Dr. Alvin T. Durant, seconded by the Rev. Dr. Heath Cheek. The motion carried.

Dr. Alvin T. Durant inquired about Rev. Carla Nelson who received Local Deacons orders is listed on the report. Bishop asked Rev. Carla Nelson Chambers to come forward. Bishop received a motion from Rev. Leslie Barnett Davis to remove Local from Rev. Nelson's Deacons order, seconded by Dr. Evalina Huggins. The motion carried.

The Committee presented Rev. Lisa Brock, Rev. Carla Nelson Chambers, Rev. Karen Kennedy, Rev. Michael Otinda, Rev. Shawnta Privette, Rev. Michael Stanley and Rev. Marlon Carter to be elected to the office of Elder in the life of the church. Bishop Moore advised the candidates and conference that ordination is not earned, it is a gift of the church. Therefore, if one chooses to leave the church, one's credentials must be returned to the church.

The 188th Session of the Philadelphia and Baltimore Afternoon Business Session continued

A motion to receive those being recommended to be elected to the office of Elder was made by the Rev. Dr. Frances Toni Draper and seconded, by Rev. Samuel Whittaker. The motion carried.

A local Deacon and local Elder can be ordained without being admitted into the Annual Conference. A local Deacon can only administer the sacraments within their local churches. A local Elder can consecrate the elements only within the local church. A traveling minister usually does not have "local" status.

Bishop called for the announcements, which the secretariat provided. Bishop asked that all Pastors invite the local church trustees to a meeting on tomorrow morning.
